

On the recommendations of the Committee, the ~~Vice-Chancellor has~~ been pleased to revise the fee structure of BBA / BCA courses in all the Private Colleges affiliated to H.P. University from the Academic Session 2013-14 as per annexure A & B. The levy charges @ 10% on tuition fee from each students from all the Colleges/Institutions will have to be remitted in the University account within 30 days after completion of the admission process failing which 10% interest will be charged extra. The levy charges would also be applicable for the students while taking admission in 2nd and 3rd year of both the courses. The said amount may be sent in the shape of DD in favour of the Finance Officer, HP University, Shimla-5. No College/Institute will charge extra amount over and above prescribed charges.
